Re: Review of PUD applications


Dear Commission Members:

We have been asked by our client, Valley Advocates for Responsible Development, to prepare a primer regarding the review of planned unit development (PUD) applications in Teton County. Accordingly, we present for your consideration the attached memorandum, which outlines the review process and addresses several common questions associated with that process.
